The Journal of Value Inquiry is a peer-reviewed scholarly publication. It publishes as "Articles" philosophical essays up to 25 pages in typescript. Two-part essays, each part able to stand alone, and totaling no more than 50 pages, will be considered. In the "Forum" section the Journal welcomes non-polemical responses to its recent essays or reviews, limited to 10 typed pages. "Reports" are published of major scholarly conferences and other activities in the field of values, limited to 15 typed pages. "Survey" articles on themes in value inquiry and essays on "Classical revisited" are generally invited.

In addition to "Book reviews" of recent publications, the Journal welcomes short "Second look" essays on neglected books and full-length "Review articles" on major recent works. "Interviews" and "Dialogues" are organized by the Editors, involving outstanding contributors to the field. The Journal publishes "Special issues" on major topics, as well as shorter "Symposium" treatments. The language of the journal is English.

Online Manuscript Submission

Manuscripts submitted to INQU must be offered exclusively to the Journal and prior to publication, accepted articles must conform to the formatting requirements as stated below.

Authors, editors and reviewers of INQU can now make use of Editorial Manager, Springer's fully web-enabled online manuscript submission and review system. To keep the review time as short as possible (no postal delays!), we encourage authors to submit manuscripts online. Editorial Manager offers authors the option of tracking the progress of the review process of manuscripts in real time.

Editorial Manager offers easy and straightforward log-in and submission procedures. This system supports a wide range of submission file formats: for manuscripts - Word, WordPerfect, RTF, TXT and LaTeX; for figures - TIFF, GIF, JPEG, EPS, PPT, and Postscript.

NOTE: By using Editorial Manager, it is NOT necessary to submit the manuscript also in printout + disk. In case you encounter any difficulties while submitting your manuscript on line, please get in touch with the responsible Editorial Assistant by clicking on "CONTACT US" from the tool bar.

Style/Format

1. Manuscripts must be submitted electronically through Editorial Manager with double spacing in 12pt font throughout, including block quotes and notes. All pages should be numbered consecutively starting from the cover sheet as page 1.

2. Articles may have sections, with the headers of the sections numbered with regular Arabic numerals and the leading letters other than prepositions and conjunctions capitalized. Sectioning should not be excessive and sub-sections generally avoided. The first paragraph and paragraphs directly under section headers should not be indented. All other paragraphs should be indented. Extra line spaces should be included before new section headings but there should be no extra line spaces between paragraphs.

3. All references should be made in notes that appear as endnotes in a final section titled Notes. In the body of the text, the note numbers are to be superscripted and placed at the end of a sentence with only one note number per sentence. In the Notes section, the note numbers are to be kept as regular, full-sized numbers, not superscripted and followed by a period, with the body of the note indented as a block. Full bibliographic information should be given with "See" used for references that are not for quotes. Please reserve endnotes for citation only, and avoid discussion in endnotes. "Ibid." and "op. cit." should be used where appropriate:

4. Except in contexts of direct quotation:

Remove all scare quotes. Omit the quotation marks and keep the word or phrase; omit the word or phrase; change the word or phrase to a word or phrase with precisely the right meaning; or precede the word or phrase with "so-called," "ostensible," or "purported." Reserve quotation marks for quoting and the use-mention distinction.

Do not use verbs of action with subjects that cannot act. Rewrite all instances of phrases such as “this paper argues,” “the argument assumes,” “utilitarianism says,” “deontology holds,” or “Platonism concludes.”

Do not use the slash mark, as in “and/or” or “he/she.”

Use American spellings and American quotation conventions. In Word, set the language to “English (U.S.)” Place all commas and periods inside quotation marks, except when doing so would result in two punctuation marks together.

5. References to books should include the author’s name, full title, place of publication, publisher’s name, and date of publication.

6. References to journals should include the author’s name, full title within quotation marks, name of the journal, volume number, year of publication, followed by the page(s) to which reference is being made. Follow the format, shown below:

Proofs

1. Authors will receive a link to the online proof and (a link) to the supporting documents (CTS form, offprint form, etc.) by e-mail from the typesetter. The manuscripts in their accepted form will be considered to be definitive and an excessive number of alterations may be charged to the author.

2. Please send the corrected proof by e-mail to the typesetter within the time limit announced in the e-mail of the typesetter. See information in the supporting documents on how to submit corrections to the typesetter.

Offprints

1. Authors of articles (not reviews of other items) will receive 50 offprints free of charge.
